- AGREEMENT TO OFFICIAL RULES: Participation in the "#StewardStars" (the "Contest") constitutes
 Entrant's (as defined below) and Winner's full and unconditional agreement to and acceptance of these Official
 Rules and the decisions of Sponsor (as defined below), which are FINAL AND BINDING in all respects. RULES
 ARE SUBJECT TO CHANGE WITHOUT NOTICE. Winning a Prize is contingent upon fulfilling all
 requirements set forth herein.
- 2. Entry must include a statement describing how their girls' team (the "Nominee") is a #StewardStar and worthy of receiving a basketball clinic. Nominees must be an organized high school, recreational or club team. Entries must also include entrant's name, address, a valid email address, and your Nominee's name, phone number and/or email address ("Contest Submission"). Limit one (1) entry per individual. Incomplete and duplicate entries will be void. If entrant is under the age of 18, permission from legal guardian must be granted. All Contest Submissions become the property of the Administrator and will not be acknowledged or returned. All information submitted is subject to the privacy policy accessible at www.phoenixmercury.com or by request.
- 7. WINNER(S) SELECTION: Representatives of the Administrator and Sponsor ("Judges") will judge all eligible Contest Submissions. To determine Prize Winner the Judges will select the most compelling Nominee (as determined by the Judges) based on the level of service and dedication possessed by the team as expressed by the entrant in the Contest Submission. The Judges will select one (1) Nominee to be the Grand Prize Winner. In the

event of a tie, an additional, tie-breaking judging will determine the Winner from among such tied entries.
