Phoenix Suns "Watch and Win 2020" Official Rules

- AGREEMENT TO OFFICIAL RULES: Participation in the "Phoenix Suns Watch and Win" (the "Promotion") constitutes entrant's full and unconditional agreement to and acceptance of these Official Rules and the decisions of Sponsor/Administrator (as defined below), which are FINAL AND BINDING in all respects. - 2. All entries become the property of the Administrator and will not be acknowledged or returned. - 7. WINNER(S) SELECTION: Administrator will conduct one (1) random drawing after each one of the broadcast games during each Game Promotion Period, in which Administrator will randomly select one (1) Per-Broadcast Prize Winner from all eligible entries (each, a "Per-Broadcast Winner"). If Administrator decides to reconvene the Promotion after a suspension, the determination of the Winner(s) will be made, from among all eligible, non-suspect entries received as of the date of the suspension, as Administrator determines in its sole discretion.
- **13. DISQUALIFICATION**: Failure to comply with these Official Rules may result in disqualification. Administrator reserves the exclusive right to disqualify any individual from the Promotion that it finds, in its sole discretion, to be tampering with the entry process, or the operation of the Promotion, to be acting, or be, in violation of the Official Rules; or to be acting in an unreasonable, non-sportsmanlike or disruptive manner, or with intent to annoy, abuse, threaten or harass any other person or interfere in any manner with any aspect or portion of this Promotion.
