**“Educator of the Month”**  
**Official Rules**

**NO PURCHASE NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCES OF WINNING. PROMOTION IS SUBJECT TO ALL APPLICABLE FEDERAL, STATE, AND LOCAL LAWS AND REGULATIONS. VOID WHERE PROHIBITED.**

1. **AGREEMENT TO OFFICIAL RULES:** Participation in the “Educator of the Month Promotion” (the “Promotion”) constitutes Entrant’s full and unconditional agreement to and acceptance of these Official Rules and the decisions of Sponsor and Administrator (as defined below), which are FINAL AND BINDING in all respects. RULES ARE SUBJECT TO CHANGE WITHOUT NOTICE. Winning a prize is contingent upon fulfilling all requirements set forth herein.
2. **ELIGIBILITY:** The Promotion is open to legal residents of Arizona, who at the time of participation, are at least fifteen (15) years of age or older and are not current members of any high school, college or club basketball teams (“Entrant”). Entrants must be currently enrolled as a student in high school, college or other educational institution. Nominated educators (“Educators”) must be employed currently as an educator. Only one (1) individual may be identified as an entrant. All directors, officers, volunteers and employees of Northern Arizona University (“Sponsor”), Suns Legacy Partners, L.L.C., dba the Phoenix Suns, (“Administrator”), the National Basketball Association and its Teams, NBA Properties, Inc., Sports & Entertainment Services, L.L.C., Phoenix Arena Development Limited Partnership d/b/a Talking Stick Resort Arena, and each of their respective companies, subsidiaries, affiliates, sales representatives, distributors, licensees, agents, advertising and Promotion agencies, and each of their immediate family members (spouses, parents, children and siblings, and their respective spouses), and those living in the same household as each, are not eligible to participate in or win any prize in the Promotion.
3. **CONTEST OVERVIEW:** The object of the contest is for a student to demonstrate why an educator (e.g., teacher, guidance counselor) is worthy of being named the Educator of the Month.
4. **ODDS OF WINNING:** The odds of winning a prize will depend on the number of eligible entries received during the Promotion Period (as defined below).
5. **PRIZE(S):** At the conclusion of each Sub-Period one (1) prize will be awarded to one (1) winner in each of the following categories: *Winning Educator* and *Winning Student* for a total of six (6) Educator and six (6) Student prizes (each a “Prize”)

(a) Each *Educator Prize* winner will receive -

- (i) Four (4) lower level tickets to one (1) Sponsor selected Suns home game during the 2018-2019 regular season;
- (ii) Four (4) Club Annexus dinners at the selected Suns Game;
- (iii) One (1) \$50 gift card to the Suns Team Shop, and
- (iv) The opportunity to view pre-game warm-ups from the Suns' bench before the selected Suns Game.

Approximate Retail Value \$550.00.

(b) Each *Student Prize* winner will receive -

- (i) Four (4) lower level tickets to one (1) Sponsor selected Suns home game during the 2018-2019 regular season;
- (ii) Four (4) Club Annexus dinners at the selected Suns Game; and
- (iii) The opportunity to view pre-game warm-ups from the Suns' bench before the Suns Game.

Approximate Retail Value \$500.00.

Total ARV of all prizes is \$6,300.00.

All Prizes are non-assignable and nontransferable. No cash equivalent of the Prizes will be awarded and the Prizes are not exchangeable or otherwise transferable. Sponsor reserves the right to substitute any prize in whole or in part with other prizes of comparable or greater value if the intended prize is not available for any reason, as determined by Administrator, in Administrator's sole discretion.

The date and time of the Suns game may be subject to change and cancellation. The terms and conditions of the tickets awarded as the Prizes shall govern in the event that the game is cancelled or rescheduled. The Winners and guest(s) agree to comply with all applicable venue rules and policies in connection with the Prizes. The venue has the right to remove or to deny entry to any winner or guest who engages in a non-sportsmanlike or disruptive manner, or exhibits an intent to annoy, abuse, threaten or harass any other person at the game. Any comments made by a Winner in a social media format containing material that is inappropriate, offensive, indecent, obscene, hateful, tortious, defamatory, slanderous or libelous may disqualify the winner, at Administrator's sole discretion. Administrator will not be responsible for acts of God, acts of terrorism, civil disturbances, work stoppage or any other natural disaster outside their control that may cause the cancellation or postponement of any game. All other expenses and costs, not expressly listed above, including, but not limited to, federal, state, and local taxes, parking, and ground transportation are the winners' sole responsibility. All travel risks, insurance, loss or damage due to prize acceptance or use are the sole responsibility of the winners. Neither Administrator nor Sponsor, nor their affiliates nor subsidiaries will be responsible for any loss, liability or damage arising out of a Winner's acceptance or use of any prize.

**6. PROMOTION PERIOD:** The Promotion will begin on Monday, October 14, 2018 at 9:00 AM MST and end on Wednesday, March 29, 2019 at 5:00 PM MST ("Promotion Period"). The Administrator's computer system shall be the official timekeeper. The Promotion Period shall be divided into six (6) sub-periods ("Sub-Period") as follows:

- (i) October 14, 2018 through November 7, 2018;
- (ii) November 8, 2018 through December 5, 2018;
- (iii) December 6, 2018 through December 26, 2018;
- (iv) December 27, 2018 through January 23, 2019;
- (v) January 24, 2019 through February 20, 2019; and
- (vi) February 21, 2019 through March 2, 2019.

7. **HOW TO ENTER:** To enter the Promotion, during the Promotion Period, Entrant must submit an essay describing why the entrant's nominated Educator deserves to be the Educator of the Month winner. Entrant must also complete all non-optional data requested on the online entry form at [www.nba.com/suns/naueducator](http://www.nba.com/suns/naueducator) ("Contest Submission"). Limit of one (1) entry per person during the Promotion Period. Incomplete and duplicate entries will be void. If the student is under the age of 18, permission from his/her legal guardian must be granted. All entries become the property of Administrator and Sponsor and will not be acknowledged or returned. All information submitted by entrants is subject to the privacy policy accessible at [www.suns.com](http://www.suns.com) or by request.

All entry content must be appropriate for all ages. You represent and warrant that you will not submit any content that contains (a) information that violates any obligation of confidentiality; (b) any viruses, spyware, malware, or other malicious components that are designed to harm the functionality of a computer in any way; (c) inappropriate content, for example but not limited to, profanity, defamatory statements, words or symbols widely considered offensive to individuals of any certain race, ethnicity, religious, sexual orientation or socioeconomic groups, threats to any person, place, business, or group or (d) content that infringes on the intellectual property rights of a third party including but not limited to, copyright, patent or trademark, or rights of privacy or publicity, or contain material that is or may be considered defamatory, slanderous or libelous, or portray or depict any person, product or entity in a false light. Each entrant warrants and represents that his/her entry complies with all of those conditions. Any non-complying entry will subject the entrant to disqualification in Sponsor's sole discretion. By submitting an entry, entrant grants Sponsor a worldwide, royalty free license in any and all media, now know or hereafter created, to copy, prepare derivative works, and distribute the entrant's entry materials. Entrants hereby waive in favor of Sponsor, all rights of "Droit Moral" or "Moral Rights of Authors" or any similar rights or principles of law that winner may now or later have to his/her entry. Sponsor reserves the right to alter, change or modify the entrant's entry, in its sole discretion.

8. **WINNER(S) SELECTION:** Representatives of the Sponsor and the Administrator (the "Judges") will judge all eligible entries submitted during the Promotion Period. At the end of each Sub-Period the Judges will select one (1) Educator and corresponding Entrant who nominated the Educator to be the "Educator" and "Student" prize winners, respectively from the Contest Submissions received during that Sub-Period. The Judges will select the Sub-Period Prize winners based upon the most compelling entries describing the level of service and dedication possessed by the educator as expressed by the entrant/student. All non-winning Contest Submissions will automatically roll-over into the next Sub-Period for another chance to win. Winners will be notified not less than seven (7) days prior to the selected Suns Game. All potential winners are subject to eligibility verification by Administrator. An Entrant is not a winner of any prize, even if notified of being a winner, unless and until the Entrant's eligibility has been verified. In the event of a tie, an additional, tie-breaking judging will determine the Winners from among such tied entries. Sponsor and Administrator reserve the right to not award the prizes if, in their sole discretion, they do not receive a sufficient number of eligible and qualified entries. The decisions of Sponsor and Administrator are final and binding on all matters relating to this Contest. Odds of winning depend on the total number of eligible entries received and the relative skill of the entrants.
9. **WINNER(S) VERIFICATION:** Winner will be notified by email or by telephone and will be required to execute and return an affidavit of eligibility/liability release and, where lawful, a publicity release (collectively, the "Winner's Agreement") within seventy-two (72) hours of date of issuance. Each

entrant understands that Sponsor or its respective agents may advise the United States Internal Revenue Service ("IRS") of the value of the prize awarded to entrant from entrant's participation in the Promotion the form of an IRS Form W-9, or otherwise. Entrant and Educator must currently be a legal resident of the United States to be awarded any prize. Entrant understands that prior to being entitled to receive any prize, and prior to receiving any prize, Entrant and Educator must first provide Administrator with all of entrant's applicable taxpayer identification information and other required and reasonably requested tax and tax-related documentation (e.g., IRS Form 1099), and that either Entrant or Educator's failure to provide such information to Administrator will result in Entrant's and Educator's automatic ineligibility to receive any prize. In the event: (a) such potential winner declines the prize in writing, (b) the Winner's Agreement or tax-related documents are not returned within the time period stated above, (c) prize or prize notification is returned as undeliverable, (d) the Administrator is unable to contact a potential winner within a reasonable time period, or a potential winner is not otherwise in compliance with these Official Rules, the corresponding Educator or Student prize will be forfeited and, at Administrator's sole discretion and time permitting, Sponsor may award the prize to the Entrant and Educator with the next highest score. In the event a selected Educator forfeits a prize or is otherwise disqualified, and the corresponding Entrant is otherwise eligible to win a prize, Sponsor and Administrator reserve the right, but have no obligation, to award to the corresponding Entrant a prize consisting of four (4) tickets to one (1) Sponsor selected Suns home game during the 2018-2019 regular season. Limit one (1) prize per person/per authorized account holder/per household. "Authorized Account Holder" is defined as the natural person who is assigned to the e-mail address by an Internet access provider, online service provider, or other organization (e.g., business, educational institution, etc.) which is responsible for assigning e-mail addresses for the domain associated with the submitted e-mail address. In the event of a dispute as to any e-mail entry submitted, e-mail entries submitted will be deemed made by the authorized account holder of the e-mail address submitted at the time of entry. Proof of being the authorized account holder may be required.

- 10. TAXES AND EXPENSES:** Winner is responsible for all applicable taxes (including, but not limited to federal, state, local and/or income) and other fees and expenses associated with the prize.
- 11. CONDITION/USE RIGHTS:** Except where prohibited by law, by accepting any prize, each entrant and entrant's parent or legal guardian consents to Sponsor, Suns Legacy Partners, L.L.C., National Basketball Association and its Member Teams, NBA Properties, Inc., Phoenix Arena Development Limited Partnership, Sports and Entertainment Services, LLC, and each of their respective parents, subsidiaries, affiliates, directors, owners, members, governors, officers, sponsors, employees and agents right to print, publish, broadcast and use worldwide in any media now known or hereinafter known, the Winners' names, addresses, voices, statements, pictures or other likeness, without additional compensation (other than the specific prize described herein), for public relations, advertising and promotional purposes as may be determined by Administrator.
- 12. RELEASE AND LIMITATIONS ON LIABILITY:** As a condition of participating in the Promotion, entrants agree to release and hold harmless all directors, officers, volunteers and employees of Sponsor, the State of Arizona, the Arizona Board of Regents, Administrator, the National Basketball Association and its Teams, NBA Properties, Inc., Sports & Entertainment Services, L.L.C. d/b/a Talking Stick Resort Arena, Suns Legacy Partners, L.L.C. d/b/a the Phoenix Suns, Phoenix Arena Development Limited Partnership, the City of Phoenix and each of their respective parent companies, subsidiaries, affiliates, sales representatives, distributors, licensees, agents, advertising and Promotion agencies (the "Released Parties") from and against any claim or cause of action arising out of participation in the

Promotion, or receipt or use of any prize, including, but not limited to: (a) unauthorized human intervention in the Promotion; (b) technical errors related to computers, servers, providers, or telephone or network lines; (c) printing errors; (d) lost, late, misdirected, incorrect, garbled, or incompletely received entries; (e) errors in the administration of the Promotion or the processing of entries; (f) injury or damage to persons or property which may be caused, directly or indirectly, in whole or in part, from entrant's participation in the Promotion or acceptance, receipt, use, or misuse of any prize, or travel to any Promotion-related events; and (g) any claims based on publicity rights, copyright/trademark infringement, intellectual property rights, defamation, invasion of privacy, or merchandise delivery. ENTRANT FURTHER AGREES TO RELEASE THE RELEASED PARTIES AND THEIR DESIGNEES AND ASSIGNS FROM ANY LIABILITY WHATSOEVER, AND TO WAIVE ANY AND ALL CAUSES OF ACTION, FOR ANY CLAIMS, COSTS, INJURIES, LOSSES AND DAMAGES OF ANY KIND ARISING OUT OF OR IN CONNECTION WITH THE PROMOTION OR ACCEPTANCE, POSSESSION, OR USE OF ANY PRIZE (INCLUDING, WITHOUT LIMITATION, ATTORNEYS' FEES, CLAIMS, COSTS, PERSONAL INJURIES, LOSSES AND DAMAGES RELATED TO PERSONAL INJURIES, DEATH, DAMAGE TO OR DESTRUCTION OR PROPERTY, RIGHTS OF PUBLICITY OR PRIVACY, DEFAMATION OR PORTRAYAL IN A FALSE LIGHT, WHETHER INTENTIONAL OR UNINTENTIONAL), WHETHER UNDER A THEORY OF CONTRACT, TORT (INCLUDING NEGLIGENCE), WARRANTY OR OTHER THEORY. Administrator is not responsible if any prize cannot be awarded due to travel cancellations, delays or interruptions due to acts of God, acts of war, natural disasters, weather or acts of terrorism. Failure to enforce any term of these Official Rules shall not constitute a waiver of that provision.

- 13. CANCELLATION/SUSPENSION:** If for any reason the Promotion is impaired in any way for any reason, including, but not limited to, infection by computer virus, bugs, tampering, unauthorized intervention, fraud, action of entrants, technical failures or any other causes which in the opinion of Administrator, corrupt or affect the administration, security, fairness, integrity, or proper conduct of this Promotion, Administrator reserves the right at its sole discretion to cancel, terminate, modify, or suspend the Promotion. If Administrator decides to reconvene the Promotion after a suspension, the determination of the prize winner(s) will be made, from among all eligible, non-suspect entries received as of the date of the suspension, as Administrator determines at its sole discretion.
- 14. DISQUALIFICATION:** Failure to comply with these Official Rules may result in disqualification. Administrator reserve the exclusive right to disqualify any individual from the Promotion that it finds, in their sole discretion, to be tampering with the entry process, or the operation of the Promotion, to be acting, or be, in violation of the Official Rules; or to be acting in an unreasonable, non-sportsmanlike or disruptive manner, or with intent to annoy, abuse, threaten or harass any other person or interfere in any manner with any aspect or portion of this Promotion. Any use of robotic, automatic, macro, programmed, copied, or like entry methods, shall void all such entries by any such methods, and shall disqualify any entrant using such methods from the current Promotion and any future promotions. CAUTION: Any attempt by an entrant or any other individual to deliberately damage or undermine the legitimate operation of the Promotion may be a violation of state and/or federal criminal and civil laws and, should such an attempt be made, Administrator reserves the right to cooperate in the prosecution of any such individual(s) and to pursue all remedies to the fullest extent permitted by law.

DISPUTE RESOLUTION AND CHOICE OF LAW:** Except where prohibited, entrants agree that: (a) any and all disputes, claims, and or causes of action arising out of or connected with this Promotion, or any prizes awarded, or the administration of the Promotion, or the determination of the winner(s), shall be resolved individually, without resort to any form of class action lawsuit, and exclusively by

arbitration, to take place in Maricopa County, Phoenix, Arizona pursuant to the Rules of the American Arbitration Association, then effective; (b) any and all claims, judgments, and awards shall be limited to actual out-of-pocket costs incurred, including costs associated with entering this Promotion but SHALL NOT include attorneys' fees; and (c) under no circumstances will an entrant be permitted to obtain awards for and entrants hereby waive all rights to claim indirect, punitive, incidental, and consequential damages and any other damages, other than for actual out-of-pocket expenses, and any and all rights to have damages multiplied or otherwise increased.
